Fisher's practice at Graves Garrett

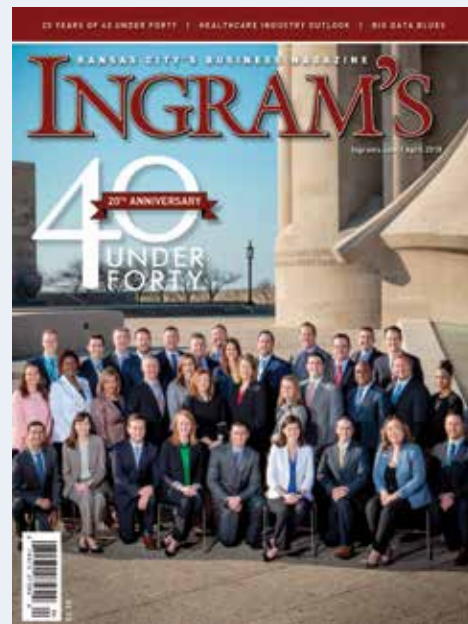

## WASHINGTON POST FEATURES COMMENTS FROM MARTIN IN RECENT ARTICLE

The Washington Post recently published an article featuring the work of Graves Garrett LLC and quoting attorney Dane Martin on the significance of a preliminary approval for settlement in the NorCal Tea Party Patriots, et al v. IRS.

Graves Garrett represents more than 400 entities in a class-action lawsuit against the IRS arising from its targeting of Tea Party cases. The preliminary total for compensation is \$3.5 million, and Martin spoke to The Washington Post on the importance of the compensation to eligible groups. Final approval of the settlement is scheduled for this summer.

Martin and Graves Garrett partner Eddie Greim have worked on the case, which is now in its fifth year. The Tea Party groups filed suit against the IRS in 2013 asserting that it targeted certain applicants for tax-exempt status on the basis of their ideological and political viewpoints.

At Graves Garrett, Martin has experience in a broad range of business litigation matters, representing businesses and individuals throughout the country. He has substantial experience defending class actions and other complex litigations against companies nationwide. In addition, Martin is also able to call on his experience in prosecuting class actions, such as in the NorCal lawsuit. He also represents clients in matters including breach of contract disputes, constitutional law, product liability, breach of fiduciary duty, regulatory compliance and investigations, securities law, and consumer protection law. ■

Appointed to the board on July 27, 2017, Garrett previously served as vice-president. The Board of Police Commissioners is responsible for overseeing the operations of the KCPD, its nearly 2000 employees and \$250 million-dollar annual budget.

Prior to entering private practice, Garrett served stints as a municipal police officer, Missouri state trooper, state prosecutor, FBI special agent and federal prosecutor. As a federal prosecutor, Garrett served as chief of the Terrorism and National Security Unit in the United States Attorney's Office for the Western District of Missouri and as an assistant U.S. attorney for the Northern District of Texas. He also served as a special assistant U.S. attorney while serving as a special agent for the FBI.

Recipient of the 2018 Lawyer of the Year recognition, Garrett's law practice focuses on federal civil and criminal enforcement defense, complex commercial litigation and false claims act (qui tam) prosecution and defense. ■

## KCMB A SELECTS ALEXANDER TO PARTICIPATE IN BAR LEADERSHIP ACADEMY

"With a daughter about ready to start high school, it's either now or never," Tompkins said. "It was the right time to come back."

Over the past eight months, Tompkins has focused on growing his practice while also acclimating himself to the Kansas City legal community. He's put an emphasis on meeting people, making professional presentations and finding outlets to publish articles to showcase his legal abilities.

Tompkins built his reputation during two separate and unique government stints. Before coming back to Kansas City, he spent three years at the U.S. attorney's office in Los Angeles, and prior to that, he served almost eight years as a trial attorney for the U.S. Department of Justice Tax Division in Washington, D.C. Tompkins wants his emphasis areas — tax controversies, white collar criminal defense, internal investigations and corporate compliance — to complement the already respected work at Graves Garrett.

"I wanted to find a place where my experience gelled with the practice," he said. "I was immediately attracted to Graves Garrett, and it was just a great fit."

Tompkins met his wife Sara Tompkins during his undergraduate studies at Pepperdine University in California, and they reconnected while he was working in Washington, D.C., and she was finishing law school in Houston. They have three children, most recently welcoming Isaac to the family this past February.
